The Daily Challenge



Preventing the spread of infection is a constant daily challenge in healthcare environments with constrained time and resources; thus the need to implement good hand hygiene behaviour is crucial in helping to optimise compliance and reduce risk.

With healthcare professionals required to perform hand hygiene as much as 50 to 100 times per day, it is also clear that keeping the skin properly conditioned is a vital part of good hand hygiene practice. Poor skin condition is known to have a negative impact on hand hygiene compliance and skin health needs to be incorporated into any compliance plan to help prevent dry, chapped and sore skin.

In a 2020 survey', the Royal College of Nursing (RCN) found that 93% of respondents reported at least one skin symptom in the preceding 12 months and 46% rated the condition of the skin on their hands as 'poor' or 'very poor'. The findings highlighted that 53% of respondents limited or stopped following recommended hand hygiene practices due to concerns that it may aggravate their skin condition.
