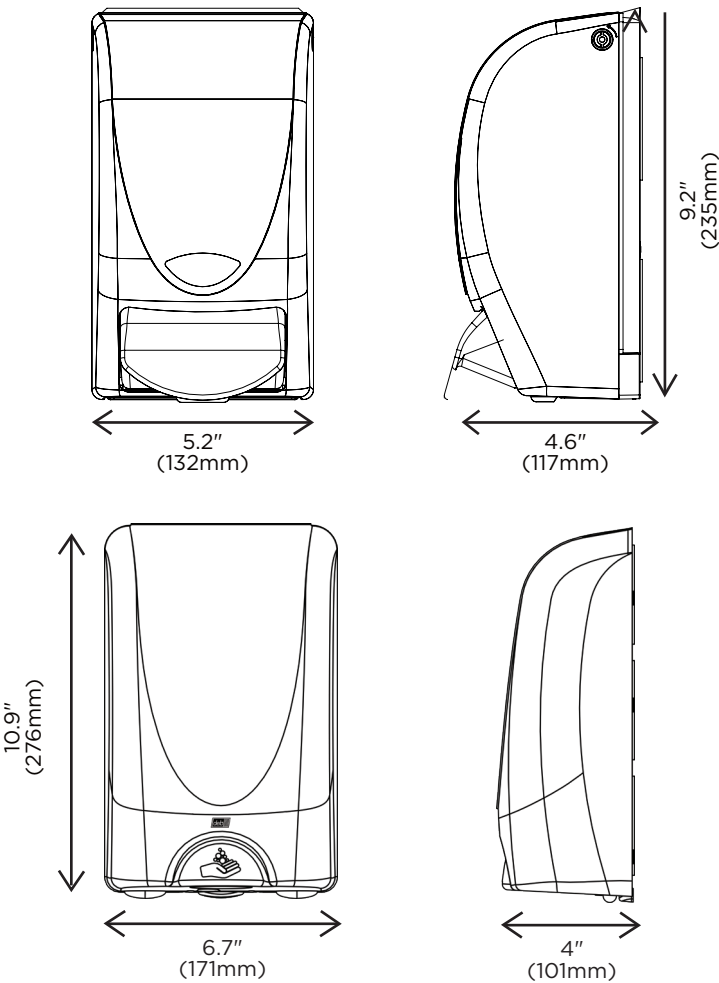
### WARRANTY
