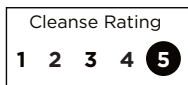

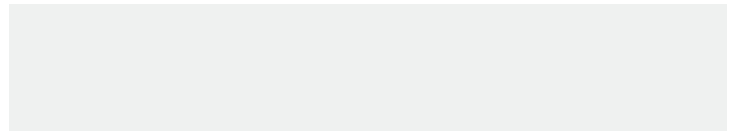
### INSTRUCTIONS FOR USE
